




# Mixing Applied Research and Graduate Studies

## Some ground rules

INRS students may be part of a research project financed in whole or in part by a private corporation **only if**:

- INRS and Corporation are not to use industrial secrets as a means of protection of the intellectual property arising from the research project; and
- the terms and conditions of the agreement do not hinder students' normal academic progress or delay earning diplomas within normal timelines

**We protect above all the right to publish for students involved in research contracts**

# Mixing Applied Research and Graduate Studies

## Managing Particular Students' Copyrights

INRS makes sure to retain the right to authorize its researchers (including its students) involved in the research project to use the results and the rights associated therewith for teaching and research purposes including for the preparation of **Proposed Disclosures**, meaning:

“any publication or presentation concerning the research project, including scientific articles, university assignments, internship or work-term reports, master’s level essays or theses, doctoral theses, thesis examinations or defences, posters, seminars, conferences, communications and any other oral or written presentation”

The counterpart of such right is usually the obligation to submit Proposed Disclosures in advance to the Corporation.

# **Mixing Applied Research and Graduate Studies**

## **Managing Particular Students' Copyrights**

The standard procedure goes as follows:

- During the Agreement and for a 24 months period following the termination date, the Corporation receives a copy of Proposed Disclosures within 45 days before the expiry of publication or presentation submission deadlines
- The Corporation must respond within 15 days. Should it fail to do so, it is deemed to consent to the public dissemination of the Proposed Disclosure
- If the Corporation objects by taking the position that the Proposed Disclosure contains its confidential information, the Parties agree on the changes to be made to the Proposed Disclosure before its submission for publication or presentation as well as on a disclosure date within 30 days from the date on which the Corporation provides its written objection

# Mixing Applied Research and Graduate Studies

## Managing Particular Students' Copyrights

The final procedure goes as follows:

- If the Corporation objects by taking the position that the Proposed Disclosure concerns intellectual property arising from the research project which is potentially patentable, the Proposed Disclosure may be made once an initial patent application is filed. If the Corporation decides not to file a patent, INRS may immediately proceed with the Proposed Disclosure without further notice
- It is possible for a Proposed Disclosure to be made within an academic programme, be submitted, defended or evaluated on a confidential basis, it being agreed that such Proposed Disclosure may be kept confidential for a maximum period of six months from the initial date on which the Proposed Disclosure is submitted to the Corporation
